

RULES FOR THE "DREAM VACATION WINNER" COMPETITION

Article 1. ORGANISING COMPANY

LAGARDERE DUTY FREE, SAS with registered capital of €5 853 930.00, whose registered office is located at: 4-6 avenue d'Alsace Tour Prisma, 92400 Courbevoie, France and registered with the register of companies (RCS) of Nanterre under the no. 380 253 518 acting in the name and on behalf of its companies (hereinafter referred to as "the Organising Company") is organising a prize competition, which is coupled with an obligation to purchase in Croatia and Poland and not coupled with an obligation to purchase in Switzerland, called "DREAM VACATION WINNER" (hereinafter referred to as "the Game") in accordance with the terms set out in these rules (hereinafter referred to as the "Rules")

Article 2. PARTICIPATION PERIOD AND LOCATION

The Game is available in the participating in Aelia Duty Free stores in Croatia, Poland and Switzerland, the list of which appears in appendix 1 (hereinafter the "ADF Stores") from 03/07/2018 at 00:01 am to 28/08/2018 23:59 pm included (hereinafter the "Game Time").

Article 3. ACCEPTANCE OF THE RULES

3.1 Entry in the Game is deemed unconditional acceptance of all the Rules, without reservation or qualification.

3.2 The participants warrant and represent that they are satisfied with all the conditions set out in the Rules for participating in the Game and agree to comply with all the provisions of the Rules, as well as the laws and regulations applicable in Croatia, Poland and Switzerland.

3.3. The Organising Company reserves the right to carry out any verifications, at any time and by any means, to check the compliance with the Rules and reserves the right to institute proceedings against any participant that violates them, by any means.

Article 4. CONDITIONS RELATING TO PARTICIPANTS

4.1 The Game is open to any natural person over the age of majority (according to the rules of the country of the participant), who is a holder of a boarding pass or an airline ticket, on the day of their participation (hereinafter the "Participant" or "Participants").

4.2 The members of the staff of the Organising Company and of its subsidiaries, any person who has directly or indirectly participated in the creation, organisation, production and/or management of the Game and/or prizes as well as their family members (spouses, partners, direct ascendants and descendants) are expressly excluded from the Game.

4.3 The Game is limited to one participation per Participant (same name, same email address and/or same receipt number if applicable) and a single win per household (same name, same email address and/or same receipt number if applicable) for the entire Participation Period of the Game.

4.4 The participation is strictly non-transferable and the Participant cannot use several e-mail addresses (regardless of how many e-mail addresses the Participant may hold) to play the Game or play on behalf of other Participants. Any Participant participating in the Game multiple times, even if they are using different e-mail addresses, shall be permanently excluded from the Game and may not, under any circumstances, receive any prizes.

4.5 Incomplete participations, sent after the deadline or in any form other than those provided for in the Rules will not be taken into consideration.

4.6 The Participant must have access to the internet and have a valid e-mail address until the time when any prize is awarded.

4.7. Any costs involved in participating or sending any elements needed to receive a prize shall not be reimbursed.

Article 5. ADVERTISING OF THE PRIZE COMPETITION

Participants may access the Game using the following URL: <https://www.dreamvacationwinner.com> (hereinafter the "Site").

The Game is advertised on promotional materials in the ADF Stores as well as on their websites and social networks.

Article 6. TERMS OF PARTICIPATION

6.01 To participate:

For Croatia and Poland:

- Go to an ADF Store during the Participation Period of the Game.
- Make a purchase (excluding tobacco and electronic cigarettes) of at least €5 in Croatia (hereinafter the "Minimum Purchase").
Or make a purchase (excluding tobacco, electronic cigarettes and alcohol) of at least 100PNL in Poland (hereinafter the "Minimum Purchase").
The purchases must be made on a single invoice at a date prior to participating in the Game.
- Keep the original receipt as well as the travel ticket (boarding pass or airline ticket).
- Go to the Site and register by completing the mandatory fields of the form (title, surname, first name, email address, airport name where the purchase was made).
- Tick the box: "I have read and accept the rules of the game".
Tick the box: "I have read and accept the privacy policy".
Tick or do not tick the "I agree to receive the newsletters of Aelia Duty Free" box
- An email will be sent to confirm registration
- Enter the unique game code, the unique password at the bottom of the receipt, and the date of purchase.
- Choose the destination of your choice from a list of 8 destinations.
- Create the corresponding postcard using the tools provided (photos and decorative frames)
- Write a message limited to 140 characters on the back of the postcard

For Switzerland:

- Go to the Site and register by completing the mandatory fields of the form (title, surname, first name, email address, airport name where the game was seen).
- Tick the box: "I have read and accept the rules of the game".
Tick the box: "I have read and accept the privacy policy".
Tick or do not tick the "I agree to receive the newsletters of Aelia Duty Free" box.
- An email will be sent to confirm registration
- Choose the destination of your choice from a list of 8 destinations.
- Create the corresponding postcard using the tools provided (photos and decorative frames)
- Write a message limited to 140 characters on the back of the postcard

For all countries:

After the download, the Participant is informed that their creation is subject to moderation. They will receive an email confirming the validation or rejection of the downloaded postcard within 2 working days.

- If the creation is validated, the Participant will be able to access it on the Gallery of the Site and will be able to share it by email and/or Facebook during the Participation Period of the Game.
- If the creation is rejected, the Participant will receive the reason for the rejection and will have to refer to the Rules. They may then post a new creation provided that it complies with the Rules.

The creations must not be damaging to the spirit of the Game and must comply with the following eligibility criteria:

- The postcard created by the Participant must represent and describe the holiday of their dreams
- Must not undermine the image of the Organising Company
- Comply with the requirements of public order and morality, and not include elements of a violent or sexual nature, in particular.
- Comply with applicable regulations and laws. In particular, do not infringe the rights of third party.

The Organising Company reserves the right to reject a creation for any reason.

6.02 To vote

The Participant may vote for as many creations as they want, but may only vote 5 times per photo. (By IP address)

There are no prizes for voting.

6.03 Eligible products (not applied for Switzerland)

All the products sold in the ADF Stores qualify for entering the Game, excluding the Alcohol products (not applied for Croatia), Tobacco and Electronic cigarette.

Article 7. DESCRIPTION OF THE PRIZES

The prizes are:

- 1 customised Holiday for one or more people worth a maximum commercial value of €10,000 including tax. The holiday is comprehensive of airline ticket/s, accommodation and airport transfers. The holiday has to be arranged with the travel agency Ker Voyages Selectour (22 Cours de Vincennes – Paris – France).

Prizes may not be returned, exchanged or replaced by any other object, service or equivalent financial reward for any reason whatsoever.

Prizes may not be exchanged.

The Organising Company will not provide any service or guarantee other than that of awarding the prizes and shall not be liable for any incident, accident and/or harm or loss that may occur as a result of using the prizes.

Article 8. DESIGNATION OF THE WINNER AND DELIVERY OF THE PRIZE

On 17/09/2018 at the latest, a Jury composed of members of the Organising Company will meet to elect the winner from among the 10 finalists who will have received the highest number of votes during the entire Participation Period of the Game.

There will be only one winner from the participating countries (Switzerland, Croatia and Poland).

The winner will be informed of their prize using the email address entered during registration and will be required to send the originals of the receipt and travel ticket (only for Croatia and Poland) and a copy of a valid ID by recorded post no later than 30/09/2018 (the date of the postmark will be decisive) to validate the win.

The winner will then be put in touch with the Ker Bastille travel agency within 8 weeks of the announcement of their winning entry. The prize is valid until June 30th 2019. After this date, if the winner has not chosen their holiday, they will be deemed to have given up the prize, which will not be put back in play.

The value of this prize can only be used to book flights, accommodations and airport transfers for the organisation of a single holiday. Any prize value that remains unused shall not be reimbursed.

The remaining value of the prize (after booking the flight(s) and accommodation) may not be transferred to a third party who is not part of the organisation of the trip.

Without prejudice to any legal action and its authority to cancel the registration of the Participant, the Organising Company reserves the right not to send the prize to the winner if the latter has provided false or erroneous contact details at the time of registration and/or if they have obviously managed to distort the outcome of the Game, by whatever means.

The Organising Company shall not be held responsible in the event of the failure to deliver the e-mail announcing the winning draw due to an error in the e-mail address provided by the Participant on the entry form for the Game, a failure of the internet service provider, an internet network failure

The winner and those accompanying the latter must ensure that their passport, visa and any other required travel documents are valid and up-to-date for any holiday they organise. No other holidays will be organised in the event that the winner cannot, for whatever reason, participate in the holiday arranged with the agency.

If the winner participated to the Game via one of the participating ADF Stores in Poland, according to the law in Poland, a flat tax of 10% constitute from the value of the prize. The winner, who the place of residence is Poland, will be obliged to pay the tax to the relevant Tax Office on the basis of his place of residence and submit a tax return on the appropriate form, for the year in which he receives the above-mentioned prize.

For the winner, who the place of residence is Poland, the 9/10 value of the prize is for the costs of the trip itself (transport, accommodation and so on) and 1/10 value of the prize is for additional expenses connected with the trip.

Article 9. CONNECTION INCIDENTS

The Organising Company shall not be held responsible for any reason whatsoever for malfunctions related to telephone and internet connections when participating in the Game, or the postponement and/or cancellation and/or modification of the campaign for reasons beyond its control.

The Organising Company shall not be held responsible for delays or errors in sending electronic mail, which are beyond its control, and shall not be held liable for the improper use of the computer or an incident related to the use of the computer (including any material or immaterial damage caused to the Participants, their computer equipment and the data stored therein, and any consequences for their personal, professional or commercial activity), the internet access, the phone line or any other technical connection.

Furthermore, the Organising Company shall not be held responsible in the event that one or more Participants cannot log on to the Site due to any technical fault or any problem related to high traffic on the network in particular for reasons beyond its control.

Article 10. FILING/AMENDING/CONSULTING THE COMPLETE RULES

The complete Rules and amendments are filed with SCP Proust et Frère, Bailiff located in Paris - 28 ter, rue Guersant - BP 50083 - 75017 PARIS.

The Rules are available, free of charge, from the ADF Stores' reception as of 3 July 2018 during opening hours and on the Site.

Only the version of the Rules filed with the bailiff shall be decisive and prevail over any other version.

Article 11. REQUESTS AND CLAIMS

Requests (written, oral or otherwise) regarding the interpretation or application of the Rules, the terms and/or mechanics of the Game and the list of winners will not be considered and no replies will be made to such requests.

In the event of a dispute or claim, for any reason whatsoever, the requests must be forwarded to the Organising Company at the address of the Game specified in article 10 within 7 days of the close of the Game (the date of the postmark will be decisive).

Article 12. PERSONAL DATA

The personal data of the Participants is to be used exclusively by the Organising Company as the entity responsible for the data processing activities.

The data that is mandatory is indicated as such on the forms. Failure to provide such information may prevent access to certain services or features of the Site and the Game itself.

The personal data is collected to validate the participation in the Game and is used to identify the Participant and issue the prize in the event that they should win.

The information collected within the framework of the Game may also be used by the Organising Company to send newsletters, subject to the prior consent of the Participant by ticking the box on the entry form.

The Organising Company may request the authorisation of the winners of the game to publish their name, first name and country in any promotional event associated with this campaign, as well as in subsequent campaigns to promote the brands of the Organising Company.

The data is kept for as long (but no longer than 3 years since the ending of the calendar year in which the prize was awarded) as it is strictly required for its purpose, except for data that must be retained for a minimum period as required by law or the regulations or the lapse of the limitation period.

Participants have a right of access, correct, transfer in case of death, delete, restrict the data processing or object to the processing of their personal data as well as a right to data portability at any time upon written request, including a copy of an identity document, to the following email address: privacy@lagardere-tr.com

Any difficulty that may arise from the application or interpretation of the Rules that is not provided for by the latter will be decided by the Organising Company.

The Rules are governed by the laws of France. Any dispute or claim relating to the performance or interpretation of these Rules that cannot be settled amicably between the parties will be referred to the courts of competent jurisdiction.
